# **SELWYN FUTURES GOLF HUB**

The role of participating golf clubs is to:

- Offer and promote membership for young people (under 19) exclusively through SFGH.
- Welcome and integrate SFGH members as part of their golf club.
- Provide full access to their golf course (subject to availability) for SFGH Members and SFGH Parent Members.
- Make their golf course and/or practice facilities available from time to time for SFGH events and programmes.
- Set up a rated purple short course.
- Provide a representative on the hub committee

#### **MEMBERSHIP**

5.1 SFGH members are affiliated through FC. Should additional Futures golf hubs be established, members of those hubs will also be affiliated through FC. Membership of SFGH shall consist of the following categories;

#### (a) SFGH Member

(i) Must be under 19 years of age on 1 September.

- (ii) Entitled to play at all participating golf clubs in the SFGH and have full use of the facilities at those clubs without payment of a green fee
- (iii) Will have a handicap maintained by FC.

# (b) SFGH Parent Member

- (i) Must be a parent or legal guardian of an SFGH member.
- (ii) Only when playing golf with their child who is an SFGH member, the parent member is entitled to play at all participating golf clubs in the SFGH and have full use of the facilities at those clubs without payment of a green fee
- (iii) Is not eligible for a handicap maintained by the FC.
